Foreign workers are required to have the proper visas and work permits in Kuwait, as established by immigration laws. Work permits must be secured for employees, and sponsored by a locally licensed and incorporated entity, which can be a problem for companies just entering the Kuwait market.

Visitors to Kuwait must obtain a visa unless they come from one of the visa exempt countries or countries eligible for visa on arrival/eVisa. All visitors except Gulf Cooperation Council citizens must hold a passport valid for 6 months.

General Laws and Regulations in Kuwait

Non-Kuwaiti passengers traveling from the following countries are prohibited from entering Kuwait until further notice: Afghanistan, Armenia, Bangladesh, Brazil, Bosnia and Herzegovina, China and Hong Kong, Chile, Colombia, Dominican Republic, Egypt, Italy, India, Indonesia, Iraq, Iran, Kosovo, Lebanon, Mexico, Moldova, Montenegro, Nepal, North Macedonia, Panama, Pakistan, Peru, Philippines, Serbia, Sri Lanka, Singapore, Spain, and Syria.

The Kuwait Civil ID is linked to your passport; losing your U.S. passport invalidates your Kuwait Civil ID. You may enter Kuwait as a visitor using a U.S. emergency passport per the advice above. You have the right to retain your passport at all times in Kuwait.
