What Is the America Invents Act? The America Invents Act (AIA) adopts a First to File approach to the United States patent statute for patents such as a utility patent. This patent reform legislation prioritizes patent filing date over invention date.. Also known as the Leahy-Smith America Invents Act, it was signed into law on September 16, 2011.
